

EXTRACT FROM THE MINUTE BOOK 1910

The Annual Parish Meeting and Election of Parish Councillors was held in the Schoolroom on Monday the 14th day of March 1910 at seven o'clock in the evening.

Present Mr Foottitt, chairman of the Parish Council, Revd. W.H. Williams, Mr Woodward, Mr C Bourne, Mr Clipsham, Mr Walton, Mr Thompson, Mr Friend and about thirty others interested.

Proposed by Mr and seconded by Mr that Mr E C Walton take the chair for the evening.
Carried unanimously.

The Chairman having taken the chair then asked for nomination papers to be handed in and after looking them through and found them valid he asked the Electors to ask the candidates any questions before he took a poll or show of hands for each candidate there being no question asked he at once put them before the meeting in order as prescribed by the orders of Local Government Order with the following result:

The Chairman asked if a Poll was demanded there being no Poll demanded he then declared the following persons duly elected to serve on the Parish Council for the following three years, Bellamy Thomas, Foottit Thomas Weightman, Dye Robert Page, Goodman Thomas William Gunnel, Smalley John William, Thompson Thomas, Williams Walter Hanwell.

The Minutes of the last meeting and the Charities report were read out to the meeting. It was a unanimous decision that these be passed as read.

It was proposed by the Revd W.H. Williams and seconded by Mr C. Bourne that in the opinion of this meeting steps should be taken to get a Passengers Station at North Muskham. This was carried unanimously. Discussion as to steps to be taken, agreed to hold a special Parish Meeting be called to discuss the best method to be used to procure a Station at North Muskham.

It was agreed to hold the meeting on 21st April 1910 and to invite representatives from Bathley, Caunton, Norwell, Cromwell, Holme and South Muskham.

The next Parish Council Meeting was held on 30th March 1910, Mr Foottit Chairman and Messrs Goodman, Smalley, Bellamy and Thompson were present.

The only business recorded is The Letting of The Lanes, when it was agreed that a letter be sent to the Chairman of Bathley Parish Meeting and one to the Surveyor of Highways for the North District of the Southwell Rural District Council setting that they are not to let any Lanes belonging to the parish of North Muskham to wit from Foxholes Lane round towards North Muskham and round towards Mouse Hall.
